November 9, 2011

1.0 Minutes of October 3, 2012

Minutes accepted as circulated.

2.0 Presidents Report

Volunteers

Diane Sargent reported that Brenda Grainger had volunteered to help with Board activities. However, due to family responsibilities, she needs to postpone her involvement to later in the year.

Diane reported that Synchro Spirit Skate information will be placed on the Bulletin Board and the newsletter to help promote that event.

Newsletter

The newsletter was discussed and the suggestion to have a separate newsletter for CanSkate was considered. Diane also reported that Sharon Black recommended that the newsletters be labeled to ensure that everyone received a newsletter. Handing out newsletters in alphabetical order would also assist in getting the newsletters out easily. Processes for easy collection of information, including Synchro information was also discussed. The members agreed to consider the above items further as the next newsletter is developed.

Bring a Friend

Diane asked Skate Canada to clarify the requirements for a "Bring a Friend" day. Skate Canada confirmed that we could have skaters bring a guest if we still run our regular program.
